

**RELEASE, INDEMNITY, AND ASSUMPTION OF RISK AGREEMENT**

FOR GOOD AND VALUABLE CONSIDERATION, INCLUDING BUT NOT LIMITED TO PERMISSION TO PARTICIPATE IN THE \_\_\_\_\_ (Name of Motorcycle Ride) \_\_\_\_\_ AND INTENDING TO BE LEGALLY BOUND HEREBY, the undersigned, being over the age of \_\_\_\_\_ years, on behalf of themselves, their spouse, children, next of kin, dependents, estate, heirs, beneficiaries, representatives, administrators, agents, successors, and/or assigns, do hereby voluntarily agree as follows:

I understand that operating and/or riding on a motorcycle and/or participating in a group motorcycle ride is inherently dangerous and involves serious risks, foreseeable and unforeseeable, (hereinafter referred to as “**RISKS**”), of serious bodily injury, emotional distress and/or emotional harm, brain injury, disfigurement, paralysis, death and/or property damage (hereinafter referred to collectively and separately as “**HARM**”), caused by or arising out of, among other things, dangerous conditions of, on, or appurtenant to the roadway, weather conditions; negligent, grossly negligent, reckless, intentional, or criminal acts of others; inexperienced or unlicensed riders; poorly or improperly maintained motorcycles; negligent planning, organizing, supervising; inadequate, negligent and/or improper traffic control, security, rescue or emergency actions and/or emergency medical services, and/or other causes not specifically mentioned herein, and that said **HARM**, may result in damages for which I, my spouse, my estate, heirs, representatives, dependents, next of kin, and/or beneficiaries would have a right to recover, including but not limited to, medical expenses, past and future income loss, loss of earning capacity, pain, suffering, embarrassment, humiliation, loss of consortium or for wrongful death, (hereinafter referred to as “**DAMAGES**”).

NOW, THEREFOR: understanding the **RISKS**, potential **HARM**, and the right to recover **DAMAGES**, on behalf of themselves, their spouse, children, next of kin, dependents, estate, heirs, beneficiaries, representatives, administrators, agents, successors, and/or assigns, or others who or which would have a right to recover damages, do hereby voluntarily:

1. WAIVE, RELEASE, DISCHARGE, AND AGREE THAT I WILL NOT MAKE ANY CLAIMS AGAINST OR SUE: \_\_\_\_\_ (Correct Legal Name of Organization) \_\_\_\_\_, its Affiliated Organization, Entities, Associations, or Partners, its/their owners, stockholders, members, officers, directors, committees, employees, representative, agents, sub-contractors, organizers, planners, volunteers, road master(s), blockers, promoters, sponsors, advertisers, insurers, consultants, or attorneys, their officers, directors, agents, employees, and representatives, successors and assigns, (hereinafter referred to as "Releasees"), for any **HARM** or **DAMAGES** arising out of or as a result of **ANY PAST, PRESENT, OR FUTURE NEGLIGENCE ON THE PART OF RELEASEES**, breach of contract, breach of warranty, express or implied, and/or for contribution or indemnity.
2. INDEMNIFY AND HOLD RELEASEES HARMLESS, including attorneys fees and costs, for any claims, legal actions or liability arising from **ANY HARM, INCLUDING HARM CAUSED BY ANY PAST, PRESENT, OR FUTURE NEGLIGENCE OF RELEASEES**, breach of contract, breach of warranty, express or implied, and/or for contribution.
3. ASSUME ALL RISK OF **HARM, INCLUDING HARM CAUSED BY ANY PAST, PRESENT, OR FUTURE NEGLIGENCE OF RELEASEES**.

It is expressly and explicitly understood and agreed that **THIS RELEASE, INDEMNITY AND ASSUMPTION OF RISK AGREEMENT EXTENDS TO AND INCLUDES ALL PAST AND FUTURE NEGLIGENCE OF RELEASEES** and is intended to be as broad and inclusive as permitted by law. *I also give full, general permission to Releasees to use or share my name, picture, likeness, video, recordings, or statements of any kind in any medium, for publicity or other purposes, without compensation or remuneration.*

I HAVE READ THIS AGREEMENT, UNDERSTAND ITS TERMS, AND AGREE THAT I AM GIVING UP SUBSTANTIAL RIGHTS, AND THAT I AM SIGNING IT FREELY, VOLUNTARILY AND WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME, AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF LIABILITY, INDEMNIFICATION, AND ASSUMPTION OF RISK, TO THE GREATEST EXTENT ALLOWED BY LAW. I FURTHER AGREE TO WAIVE ALL BENEFITS FLOWING FROM ANY STATUTE, LAW, OR REGULATION THAT WOULD LIMIT THIS AGREEMENT. THIS IS THE ENTIRE AGREEMENT, AND IF ANY PORTION IS HELD TO BE INVALID, THE BALANCE SHALL CONTINUE IN FULL FORCE AND EFFECT.
